About the Workshop

We will hear from Andrew Janzen of Janzen Insurance Brokers, who is recognized as a farm insurance expert, and is also currently serving as the President of the Insurance Brokers Association of BC.

Through his board involvement, Andrew had the opportunity to meet with the top insurance company CEOs to discuss challenges and opportunities facing the insurance industry in Canada – Andrew will share insight on this, and how this affects farmers in BC. Andrew will also touch on other current issues such as overland water, disease, how to address increased construction and equipment costs, and how the changes at ICBC affect farm vehicles and farm fleets.

Andrew will outline what he recommends when looking at farm insurance, and identify ways to save money on your farm insurance. He will close off with a discussion on things to consider when transitioning the farm from one generation to the next.
